DRAFT MEETING MINUTES August 14, 2002

Co-Facilitators Theresa Fishler and Ken Hobbs called the meeting to order at 6:35 pm. An agenda was shared and all present introduced them. The draft agenda included a time to discuss the minutes of the July meeting and details of the upcoming event on Saturday, September 22, 2002.

Minutes of the July 10, 2002 meeting and the agenda for the August 13 meeting were approved.

A group of parents in the Middleton-Cross Plains district has invited the Dane County People Can't Wait Coalition to be a part of a meeting for parents on September 25th. We will accept.

Theresa Fishler has agreed to set up a web page on the Community page at www.Madison.com. Way to go Theresa. Ken will assist.

A desire for a Kickoff event was expressed at the May 9 meeting. After considerable discussion, a committee was appointed to check out the feasibility of an August 25 event or a suitable alternative. The committee (chaired by Ben Topp and including Liz Hecht, Helen Hartman, Dennis Harkins and Dan Remick) reported on their progress at the July 10 meeting. A flyer has been widely circulated and the September 22 event, a picnic, was the major topic at the meeting.

Volunteers are needed and we also need chips/dip and some supplies.

Barb Katz – will be asked to plan some games for the kids

We paid \$79.13 for the park shelter use fee.
